Roll Call - Dena Irwin

Secretary, Dena Irwin, called the roll. Fifteen members were present and a quorum was established.

Approval of Minutes - Dena Irwin

Minutes from the November 29 Virtual Administrative Board Meeting were emailed by Karen. Karen created the minutes in Dena's absence. Karen brought up that the minutes indicate on the Standing Committee Reports for Awards that no vote was taken to increase the award amount to \$500. Linda Harper moved to approve the November 29, 2011 minutes with the correction to show that the motion to increase award budget died for lack of a second. Jason seconded. Motion carried.

Treasurer's Report - Twana Hulen (see green sheet Appendix A)

"As we draw near to the close of the 2010-11 fiscal year I am pleased to report that we are currently within our planned budget amount. I also feel confident that we will be able to maintain our positive budget through the end of the year.

Our current income stands at \$12,105.50 and current expenses, \$9,067.68. This is a current net income of \$3,037.82. We also have an invoice outstanding for CD's sold to Nebraska Department of Education for \$1,160. I am estimating our remaining expenses at \$4,000. If my estimates are close we will be able to finish this fiscal year in the black, and this is without using any of the funds that we had in the bank at the beginning of the year on July 1, 2010.

Seven states, Illinois, Indiana, Iowa, Michigan, Missouri and Ohio, participated in the NBEA Professional Development Partnership Program with a check for \$200. Wisconsin participated with a check for \$100. I sent Janet Treichel a check for \$1,200 for six \$200 stipends. This leaves a balance of \$100 in the fund.

The NCBEA Past Presidents fund has a balance of \$995. Checks totaling \$240 have been received this fiscal year.

CDs are continuing to sell with the Nebraska Department of Education recently submitting an order for \$1160.

This has been a good year for NCBEA financially. We are currently still within our budget and I expect it to close without going over the budgeted amounts and show a net income on June 30, 2011."

EXECUTIVE OFFICERS' REPORTS

President - Karen Drage

"The annual NCBEA Improvement Plan report was submitted to NBEA. The report outlined our efforts this year to add value to membership in NBEA. The webinars, Facebook page, database, and the members' only section of our Web site were all included in the report. Once again NCBEA reported that sending out hard copies of the newsletter is not feasible for us at this time. The report also asked for the expenditures for membership recruitment. At the time of the report, only \$883.31 had been recorded in the budget as expenditures for membership

recruitment. A statement concerning our past financial challenges and the state representative's reluctance to spend NCBEA funds was included in the report; however, NCBEA can expect to receive recommendations on improving our recruitment efforts.

Our budget is a constant concern. Due to the drop in membership, our 2010-2011 budget was nearly \$4,000 less than what had been expected. Tough decisions will have to be made if NCBEA is going to stay solvent in 2011-2012 and beyond. Decisions that will need to be made will include continuing to reimburse travel expenses, NCBEA conference location, membership recruitment, and rebates, and fundraising. Membership has to be our priority. Overall, it has been a productive year for NCBEA despite our challenges. If NCBEA is going to prosper in the upcoming years, it will require that the administrative board work together and support each other."

President-elect - Margaret Erthal

"The Chicago July 18, 2011 workshop is coming together. I have secured six speakers, but need speakers from these states: Illinois, Indiana, Wisconsin, Iowa, and Minnesota. Free financial literacy curriculum CDs will be available at one of the sessions. Two research sessions are scheduled in addition to a tour of the Federal Reserve Building. Please continue to publicize this workshop. We will make around \$25 profit per person.

NCBEA and Wisconsin will co-host the Sept 29-30, 2011 conference in Green Bay. NCBEA will have a hospitality room and provide speaker sessions. I hope the administrative board will be able to attend and participate in the conference as we have all done in the past. I have been asked to speak at the Michigan conference in East Lansing in November."

- Beth has received donations amounting to \$240.
- We can offer three \$200 stipends to first time attendees.
- Six are attending but 13 are not attending.

"The board is happy we are offering a summer workshop and the free webinars. We should use the NBEA social networking resources. They are happy we are making progress and trying to incorporate as many of their suggestions as possible. We need to keep self-evaluating our progress by looking back at our reports and then the regional evaluation should be viewed within our own region.
